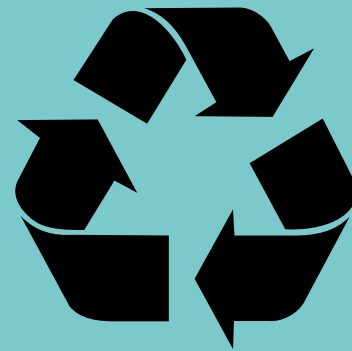


Close the Loop Global

OBJECTIVE

Close the Loop Global (CTL) provides innovative sustainability solutions, including product stewardship, materials recovery, and the production of recycled-content products. As a leader in circular economy practices, CTL needs to validate and communicate the environmental impact of its operations with accurate, auditable data. With CarbonSuite, CTL was seeking a robust system to manage the increasing demand for sustainability disclosures across its global operations - spanning Australia, North America, South Africa, and Belgium. CTL required a single integrated system that could consolidate sustainability data across multiple diverse business units and geographies.

SOLUTION

CarbonSuite was implemented as CTL's centralized platform for sustainability data management, tracking emissions and other environmental data across all operations. The platform integrates directly with CTL's operational systems to automate data collection as much as possible. During implementation, we collaborated with logistics providers & travel partners to collect direct Scope 3 activity data, improving accuracy and traceability of reporting. Additionally, CTL now has the ability to integrate activity data used for other reporting like the Australian Packaging Covenant Organisation (APCO), which can be converted into emissions. These collaborations enable CTL to move beyond estimates and support its environmental claims with verifiable data.
